Player's Club Agreement TAHQUITZ CREEK GOLF RESORT

The Player's Club Pass entitles the Passholder and, if applicable, any included family members to the following benefits:

- ❖ \$12 Legend Cart / \$15 Resort Cart Access fee golf at specified times (see attached)
- ❖ Up to 3 Day Advance Reservations
- ❖ 2 Draft Beers or Fountain Drinks with each cart / access fee round
- ❖ 1 Large Bucket of Range Balls per day
- ❖ 20% discount on purchase of range keys
- ❖ Complimentary weekly professional instructional clinic access
- ❖ Players Club Corner with the ability to purchase select merchandise at Club cost
- ❖ USGA handicap service through our selected handicap system

The Player's Club Pass shall be issued in the name of the Passholder. Player's Club Pass benefits may be extended to family members 18 years of age and younger for an additional monthly fee as set forth below. Passholder acknowledges that children under 16 years of age must be signed into Tahquitz by a parent or guardian, and children under 11 years of age must be accompanied by a parent or guardian while at Tahquitz. Family members include spouse and children living in the same home. Upon execution of the Agreement and payment of the Plan Fee indicated below, the Player and named family members shall receive all Plan benefits and privileges. Passholder shall at all times comply with the Rules and Regulations and other policies of Tahquitz. Any member found giving range balls to other guests, members, or removing range balls from the facility will be immediately expelled from Players Club. I further understand that Tahquitz has up to 30 days to cancel the agreement at that point and that some billing may occur after the date of written notification. Player's Club benefits are not included with tournament play, league play, or any other organized group or membership play, including Men's Club, and/or Ladies' Club. I also understand that my Players Club privileges may be revoked with or without refund for abuse of facility, its property, or its staff.

The term of this Player's Club Agreement (this "Agreement") is one (1) year and shall commence on the date this Agreement is executed and payment of the first monthly Plan Fee is received by Tahquitz. After the initial one (1) year either party may terminate this Agreement by giving thirty (30) days advance written notice of termination. Passholder is responsible for all fees incurred during the thirty-day (30-day) notice period, regardless of which party elects to terminate. Upon termination by Passholder, Passholder agrees to pay all then current unpaid Plan Fees and charges, plus an amount equal to one additional monthly Plan Fee (last month). Tahquitz may modify the monthly Plan Fee and benefits upon at least thirty (30) days advance written notice to Passholder.

Passholder may choose to make payments on a month-to-month basis for this annual Player's Club Pass and if doing so agrees to make timely payment of the monthly Plan Fee and any and all other charges incurred by Passholder. Passholder agrees to maintain a current credit card account in Passholder's name on file with Tahquitz at all times. Credit card on file will be used to bill Plan Fees each month. Plan Fees are payable on the first day of the month, in advance. Passholder agrees to immediately notify Tahquitz of any changes in credit card information. Passholder further agrees that Tahquitz is not responsible for any fees incurred as a result of the Tahquitz billing Passholder's credit card (e.g., for overdrawn accounts, exceeding credit card limits, etc.). **Passholder understands that the monthly Plan Fee will not be waived under any circumstances, regardless of whether the Passholder exercised the benefits of the Player's Club Pass in a given month.**

The Plan Fee is as follows (Add up to two (2) Family Members for \$19 each per month) (Monthly Option \$10 per Family Member.)
